Dear Governor Hochul,

We urge you to stop the expansion of the aging over 30-year-old Iroquois natural gas pipeline. The expansion project, if approved, will significantly increase the volume of fracked gas flowing through the pipeline by expanding two polluting compressor stations in the Hudson Valley region—in Athens and Dover—and two additional compressor stations along the pipeline's route in Connecticut.

This proposal poses an imminent threat to the health and well-being of our state and the communities we were elected to represent. Compressor stations have a documented history of emitting cancer-causing chemicals, including elevated levels of nitrogen oxide (NOx), fine particulate matter, carbon monoxide, benzene, and formaldehyde. The harmful effects of NOx and particulate matter pollution on respiratory health are well-established, contributing to chronic bronchitis, asthma, emphysema, aggravated heart diseases, difficulty breathing, and reduced life expectancy. New Yorkers have a right to clean air, clean water, and a healthful environment as a result of the Green Amendment (that passed overwhelmingly in 2021) and this proposal would be infringing upon those rights.

Pipeline infrastructure, including compressor stations, are historically dangerous. Simply add a spark to a two-minute compressor station gas leak and within two seconds an explosion could cause death or severe second degree burns to those nearby. According to an [NRDC](#) report published in 2019, natural gas pipelines led all pipeline infrastructure in injuries, deaths, fires, evacuations, and explosions. In August 2023, the [Environmental Defense Fund](#) reported on methane leaks from pipelines and found that U.S. natural gas pipelines are leaking between 1.2 million and 2.6 million tons of methane per year. In 2022, a report from the [U.S. PIRG Education Fund, Environment America Research & Policy Center and Frontier Group](#) revealed that 2,600 hazardous gas pipeline leaks in the United States caused more than \$4 billion in damages and emergency services, killed 122 people, and released 26.6 billion cubic feet of fuel as methane or carbon dioxide. Doctors Russo and Carpenter, from Institute for Health & the Environment in Rensselaer NY told the Sierra Club, [“In our opinion, the routine emissions surrounding the operation of natural gas compressor stations in New York State \(NYS\) increase the risk for most major categories of human disease in the state but especially in the communities where they are sited.”](#)

The Iroquois pipeline expansion by compressors proposal, if approved, would put New Yorkers at great risk and run fully astray of our state’s climate goals. We urge you to prioritize the well-being of the people of New York and the environment over the profits of the fossil fuel industry. Your leadership and commitment to the goals of New York's Climate Act are crucial in this pivotal moment. Continued investments in fossil fuels perpetuate our dependence on a dirty energy future.

Governor Hochul, you possess the obligation and the authority to safeguard our environment, our health, and our future. We implore you to deny the expansion of the Iroquois fracked gas pipeline and to champion a brighter, cleaner, and more sustainable future for all New Yorkers.
